ADDITIONS TO THE AGENDA

There were no changes to the agenda.

MINUTES

Upon a motion by Director Phillips and seconded by Director Paregien, the Minutes of the February 11, 2020

Board Meeting were approved.

BILLS

The bills were reviewed by the Board. Upon a motion by Director Felts and seconded by Director Peltzer,

check numbers 14982-15010, inclusive and included herewith as Attachment "A" were approved.

FINANCIAL REPORT

Copies of the attached financial report for the March 10, 2020 Board Meeting, were submitted to the Board

of Directors showing receipts of \$29,425.54, total disbursements of \$81,923.13 and an active bank balance of

\$1,194,828.4 at Citizens Business Bank ending February 29, 2020 for their review. Upon a motion by

Director Paregien and seconded by Director Spruitenburg, the financial report was approved.

WATER SUPPLY

The Board was informed that the Bureau of Reclamation gave an initial allocation of 20% for the 2020 water

year.

The Board set an initial allocation of .35-acre foot per acre and a cost of \$250 per acre foot.

SUPERINTENDENTS REPORT

Manager Weddle gave an update on field activities and meter upgrades.

GROUNDWATER LEVELS

The average depth to groundwater for the month of March was reported at 101.8 feet. This was an increase in the depth to water of 1.1 feet from the prior month.

SUSTAINABLE GROUNDWATER MANAGEMENT ACT

It was reported that the East Kaweah GSA was expected to go out for a 218 election some time in April. The budget for the 218 election is \$80,000. The Board expressed concern that those voting would not be informed enough to vote in favor of the tax increase.

MANAGERS REPORT

The Board discussed the replacement of the pump shared by Rocky Hill and Bybee. The Manager explained that the capacity of the pump was no longer enough due to both Rocky Hill and Bybee wanting to take more water. There was discussion on how to share the pump replacement costs between the parties with no action until historical delivery records were looked at.

SOUTH VALLEY WATER ASSOCIATION

Alex Peltzer update the Board on the SVWA Portfolio's wet water supply projects.

CLOSED SESSION

Alex Peltzer took the Board into Closed Session to discuss existing litigation.

The Board discussed Manager Weddle's salary.

CLOSED SESSION ITEMS

The only reportable action from Closed Session was regarding Mr. Weddle's salary. Upon a motion by Director Felts and seconded by Director Peltzer, the Board authorized a 3% increase for Manager Weddle retroactive back to January 1.

OTHER ITEMS

Upon a motion by Director Peltzer and seconded by Director Paregien, the Board authorized Manager Weddle's attendance at the Spring ACWA Conference.

ADJOURNMENT

There being no further business, upon a motion presented by Director Peltzer and seconded by Director Paregien, the meeting was adjourned at 3:02 p.m. The next regularly scheduled meeting of the Ivanhoe Irrigation District Board of Directors will be held Tuesday, April 14, 2020, at 1:30 pm.
