MINUTES

Upon a motion by Director Phillips and seconded by Director Peltzer, the Minutes of the October 13, 2020 Board Meeting were approved.

FINANCIAL REPORT

Copies of the attached financial report for the November 10, 2020 Board Meeting, were submitted to the Board of Directors showing receipts of \$245,595.62, total disbursements of \$286,108.68 and an active bank balance of \$209,389.18 at Citizens Business Bank ending October 31, 2020 for their review. Upon a motion by Director Felts and seconded by Director Phillips, the financial report was approved.

WATER SUPPLY

It was reported that the District delivered 1,214 acre-feet of CVP and 377 acre-feet of Wutchumna water in the month of October. The District also recharged 104 acre-feet and received no rain for the month.

Manager Weddle informed the Board that there will be close to 1,100 acre-feet of carry-over for 2021.

SUPERINTENDENTS REPORT

Mark Davis gave an update on maintenance and the expected pipeline replacement for the off-season.

GROUNDWATER LEVELS

The average depth to groundwater for the month of November was reported at 108.3 feet. This was a decrease in the depth to water of 0.8 feet from the prior month.

SUSTAINABLE GROUNDWATER MANAGEMENT ACT

It was reported that the 218 Election for the East Kaweah GSA passed with 85% approval.

SCADA PROJECT

Upon a motion by Director Peltzer and seconded by Director Spruitenburg, the Board approved Progress Payment #3 to Nicholas Construction in the amount of \$57,000.

MANAGERS REPORT

Upon a motion by Director Felts and seconded by Director Paregien, the Board accepted the 2019 Audit Reports completed by Sciacca and Associates.

The Board reviewed the 2021 Budget along with the new Supplemental Assessment for the Proposition 218 increase. Upon a motion by Director Peltzer, and seconded by Director Spruitenburg, the 2021 Budget was approved for \$1,991,950.

The Board deferred the adoption of the new employee handbook to a later date pending some changes consistent with the prior handbook.
