Upon a motion by Director Phillips and seconded by Director Peltzer, the Minutes of the April 13, 2021 Board Meeting were approved.

BILLS

Manager Weddle reviewed the cost breakdown for the SLDMWA billing.

FINANCIAL REPORT

Copies of the attached financial report for the May 11, 2021 Board Meeting, were submitted to the Board of Directors showing receipts of \$69,122.92, total disbursements of \$126,579.71, and an active bank balance of \$269,732.01 at Citizens Business Bank ending April 30, 2021 for their review. Upon a motion by Director Paregien and seconded by Director Spruitenburg, the financial report was approved.

WATER SUPPLY

The District delivered no water in the month of April and received 0.17 inches of rain for the month, for a total of 5.29 inches of rain season to date.

The District allocation was reduced to 0.30 acre-foot per acre at a cost of \$300 per acre-foot.

SUPERINTENDENTS REPORT

Chris Marshall updated the Board on the maintenance activities in the field.

GROUNDWATER LEVELS

The average depth to groundwater for the month of May was reported at 110.0 feet. This was an increase in the depth to water of 3.4 feet from the prior month.

68 SCADA PROJECT

Upon a motion by Director Felts and seconded by Director Phillips, Progress Payment No. 7 of \$191,900 was approved.

Upon a motion by Director Peltzer and seconded by Director DeLeonardis, Progress Payment No. 8 of \$182,400 was approved.

Dennis Keller reviewed the Change Orders for the 68 SCADA Project. Upon a motion by Director Spruitenburg and seconded by Director Paregien, the Change Order of \$104,627.82 was approved.

MANAGERS REPORT

The Board discussed recharge options with the public who attended the meeting. After a lengthy discussion, the Board decided to form a technical advisory committee to evaluate feedback from the public to determine what actions might be acceptable for District planning.

Alex Peltzer discussed the Cost Sharing MOU with the Board. Upon a motion by Director Phillips and Seconded by Director Felts, Resolution 2021-01 was approved to accept the Cost Share Agreement MOU for the FKC.
