The regular meeting of the Board of Directors of the Ivanhoe Irrigation District was called to order by President Gary Caviglia, February 11, 2020 at 1:33 p.m.

OTHERS PRESENT: Manager Weddle, Mark Davis, Garrett Busch, Andrew Hart, and Craig Hornung

#### PUBLIC COMMENT

Craig Hornung informed the Board that there would be construction between August 1 and November 1 that could impact District deliveries to certain growers on the 68 Line.

#### ADDITIONS TO THE AGENDA

There were no changes to the agenda.

#### **MINUTES**

Upon a motion by Director Paregien and seconded by Director Spruitenburg, the Minutes of the January 14, 2020 Board Meeting were approved.

#### **BILLS**

The bills were reviewed by the Board. Upon a motion by Director Phillips and seconded by Director Peltzer, check numbers 14934-14981, inclusive and included herewith as Attachment "A" were approved.

#### FINANCIAL REPORT

Copies of the attached financial report for the February 11, 2020 Board Meeting, were submitted to the Board of Directors showing receipts of \$43,591.97, total disbursements of \$197,509.75 and an active bank balance of \$1,247,325.99 at Citizens Business Bank ending January 31, 2020 for their review. Upon a motion by Director Felts and seconded by Director DeLeonardis, the financial report was approved.

#### TRUCK BIDS

The bids for the surplus vehicles were opened at the Board Meeting after the winning bid from the January Board Meeting changed his mind on purchasing the Ford Ranger. The Ford Ranger received 7 new bids of

\$1,200, \$1,250, \$1,300, \$2,000, \$2,200, \$2,500, and \$2,625. Upon a motion by Director Paregien and seconded by Director DeLeonardis, the Board authorized selling the Ford Ranger to Luis Salto for \$2,625.

#### WATER SUPPLY

Manager Weddle informed the Board that the Bureau of reclamation would be allowing 10% carry-over going into the 2020 water year.

The Board received an update on the 68 Main Line SCADA Project with no start time given for construction.

#### SUPERINTENDENTS REPORT

Mark Davis informed the Board that Rocky Hill was no longer interested in cost sharing for the new pump at the Friant Canal that would increase capacity.

The Board authorized an electrical upgrade for the shop pending a second bid.

#### **GROUNDWATER LEVELS**

The average depth to groundwater for the month of February was reported at 100.7 feet. This was a decrease in the depth to water of 0.3 feet from the prior month.

#### SUSTAINABLE GROUNDWATER MANAGEMENT ACT

It was reported that the GSP's for the Greater, Mid, and East Kaweah submitted their plans on January 28.

#### MANAGERS REPORT

Upon a motion by Director Phillips and seconded by Director Felts, the Board approved Resolution 2020-01 for Agreement No. 20-WC-20-5451 for URF Water.

Upon a motion by Director DeLeonardis and seconded by Director Paregien, the Board approved Resolution 2020-02 for Contract No. 20-WC-20-5590 for 215 Water.

Garret Busch from Wonderful approached the Board regarding tying into the end of the 68 Line to test capacity for a potential conveyance project.

Upon a motion by Director Phillips and seconded by Director DeLeonardis, the Board approved appointing William Spruitenburg as the Representative along with Manager Weddle for the ACWA-JPIA.

SOUTH VALLEY WATER ASSOCIATION

Manager Weddle informed the Board that the South Valley Members were still working on having a seat at

the table for all things O&M withing the Friant Agency. It was also stated that the Transfer Agreement

between the Bureau and Friant would likely not happen without every District having a say in O&M.

**CLOSED SESSION** 

The Board went into Closed Session for Manager Weddle's yearly performance evaluation.
