MINUTES

Upon a motion by Director Phillips and seconded by Director Peltzer, the Minutes of the September 8, 2020 Board Meeting were approved.

BILLS

FINANCIAL REPORT

Copies of the attached financial report for the October 13, 2020 Board Meeting, were submitted to the Board of Directors showing receipts of \$290,791.11, total disbursements of \$225,797.96 and an active bank balance of \$249,902.24 at Citizens Business Bank ending September 30, 2020 for their review. Upon a motion by Director Phillips and seconded by Director Spruitenburg, the financial report was approved.

WATER SUPPLY

It was reported that the District delivered 734 acre-feet of CVP and 1,304 acre-feet of Wutchumna water in the month of September. The District also recharged 116 acre-feet and received no rain for the month. Manager Weddle informed the Board that there was 1,636 af of CVP and 654 af of Wutchumna remaining for the month of October.

Manager Weddle reported that the District purchased an additional 500 acre-feet from Rocky Hill Ranches.

SUPERINTENDENTS REPORT

Mark Davis gave an update on maintenance and the SCADA system operation.

GROUNDWATER LEVELS

The average depth to groundwater for the month of October was reported at 109.1 feet. This was an increase in the depth to water of 0.3 feet from the prior month.

SUSTAINABLE GROUNDWATER MANAGEMENT ACT

The Manager reminded the Board that the 218 Hearing would be October 26th.

MANAGERS REPORT

The Manager gave the 2021 Draft Budget to the Board to review for discussion at the November Board Meeting.

Doug Souza reviewed the 2019 Audit with the Board to be accepted at the November Board Meeting.

Manager Weddle gave an updated Employee Handbook to the Board to review for the November Board Meeting.

Upon a motion by Director Peltzer and Seconded by Director Phillips, the second progress payment of \$126,825 to Nicholas Construction was approved.

Dennis Keller reported that the SCADA Project was ready to start construction. He stated that the actuators had been ordered, the encroachment permits have been submitted to the county, and EPS was ready for the expansion of the current SCADA software.

SOUTH VALLEY WATER ASSOCIATION

It was reported that the Friant was still hoping to get funds from the State for the subsidence fix. It was also reported that there is a Friant District in the southern part of the Valley that has proposed paying for a portion of the fix with the expectation that they would then be entitled to first share of that additional space.
