# SUPERINTENDENTS REPORT

Chris Marshall informed the Board that Rocky Hill had received a new meter last year. It was recommended to replace that meter with a different one to check accuracy.

**GROUNDWATER LEVELS** 

The average depth to groundwater for the month of October was reported at 119.4 feet. This was an increase

in the depth to water of 1.2 feet from the prior month.

**68 SCADA PROJECT** 

Upon a motion by Director DeLeonardis and seconded by Director Paregien, Nicholas Construction

Payments No.9 (\$85,500.00), No.10 (\$99,396.43), and No. 11 (\$71,481.39) FINAL were approved.

**MANAGERS REPORT** 

The Board discussed deepening the District well due to dropping water levels.

SUSTAINABLE GROUNDWATER MANAGEMENT ACT

Manager reported that the East Kaweah GSA was working on modeling and the water accounting

framework. It was stated that the EKGSA and MKGSA would be moving forward with an allocation where

GKGSA would likely wait till 2022.

Alex Peltzer gave a Voluntary Agreement update and reviewed the potential Friant Kern Canal funding.
