ADDITIONS TO THE AGENDA

There were no changes to the agenda.

MINUTES

Upon a motion by Director Phillips and seconded by Director Felts, the Minutes of the July 14, 2020 Board Meeting were approved.

BILLS

The bills were reviewed by the Board. Upon a motion by Director Peltzer and seconded by Director DeLeonardis, check numbers 15189-15225, inclusive and included herewith as Attachment "A" were approved.

FINANCIAL REPORT

Copies of the attached financial report for the August 11, 2020 Board Meeting, were submitted to the Board of Directors showing receipts of \$419,298.55, total disbursements of \$431,452.20 and an active bank balance of \$125,728.11 at Citizens Business Bank ending July 31, 2020 for their review. Upon a motion by Director Paregien and seconded by Director Phillips, the financial report was approved.

WATER SUPPLY

It was reported that the District delivered 781 acre-feet of CVP and 549 acre-feet of Wutchumna water in the month of July. The District also recharged 120 acre-feet and received no rain for the month.

The Board decided that due to a limited water supply this season, and to encourage use, it would set a turn back date of September 15 for water or commit to pay for any balance remaining on the account on February 28, 2021.

SUPERINTENDENTS REPORT

Mark Davis updated the Board on the current repairs. There was discussion on raising the Keller weir to eliminate overflowing during start up.

GROUNDWATER LEVELS

The average depth to groundwater for the month of August was reported at 107.5 feet. This was an increase in the depth to water of 1.4 feet from the prior month.

SUSTAINABLE GROUNDWATER MANAGEMENT ACT

It was reported that any landowner could challenge the Land IQ pumping values with their own well records.

Manager Weddle reported that the final Implementation Call for Funds for the East Kaweah GSA would be suspended until the following year to allow for project completion to catch up to the current funds held by the EKGSA.

MANAGERS REPORT

The District Point of Diversion was expected to be completed by the end of the year with a cost to the District of close to \$7,000.

SOUTH VALLEY WATER ASSOCIATION

Alex Peltzer gave a brief update on the \$73,000,000 that Friant was hoping to get thru the WIIN ACT for the Friant Kern Canal fix. There was also an update on the ASO Snow Observatory Flight funding that was not currently in the Governor's budget, but efforts were in place to get the Bureau of Reclamation to fund the project.

CLOSED SESSION

There was nothing to report in Closed Session.
