FINANCIAL REPORT

Copies of the attached financial report for the December 14, 2021, Board Meeting, were submitted to the Board of Directors showing receipts of \$415,981.71, total disbursements of \$148,496.17, and an active bank balance of \$756,139.79 at Citizens Business Bank ending November 30, 2021, for their review. Upon a motion by Director DeLeonardis and seconded by Director Spruitenburg, the financial report was approved.

WATER SUPPLY

The District delivered 548 AF of CVP and no Wutchumna in the month of November. There was a .14 in of rain for the month of November.

SUPERINTENDENTS REPORT

Chris Marshall informed the Board that Willits Pump would be working with Friant to insure accurate meter readings at Rocky Hill. The Board suggested that the District get on a Well Drilling List for a new District well.

GROUNDWATER LEVELS

The average depth to groundwater for the month of December was reported 114.8 feet. This was a decreased in the depth to water of 2.3 feet from the prior month.

MANAGERS REPORT

The Board asked Manager Weddle to discuss WDM with Office Manager Egger to outline the weaknesses in the Water District Program.

Manager Weddle informed the Board that the District will be installing a sign out front with District name.
