MINUTES

Upon a motion by Director Phillips and seconded by Director Paregien, the Minutes of the May 12, 2020 Board Meeting were approved.

BILLS

The bills were reviewed by the Board. Upon a motion by Director Felts and seconded by Director DeLeonardis, check numbers 15095-15144, inclusive and included herewith as Attachment "A" were approved.

FINANCIAL REPORT

Copies of the attached financial report for the June 9, 2020 Board Meeting, were submitted to the Board of Directors showing receipts of \$73,160.92, total disbursements of \$145,562.89 and an active bank balance of \$219,459.13 at Citizens Business Bank ending May 31, 2020 for their review. Upon a motion by Director Peltzer and seconded by Director Spruitenburg, the financial report was approved.

WATER SUPPLY

It was reported that the District delivered 137 acre-feet of CVP and 107 acre-feet of Wutchumna water in the month of May. The District also recharged 47 acre-feet and received 0.6 inches of rain for the same month.

Manager Weddle informed the Board that Friant Water Authority intends to treat the Canal with Copper Sulfate each Tuesday in the month of May.

SUPERINTENDENTS REPORT

The Board was updated on current construction and meter replacements. Craig Hornung informed the Board that there was scheduled construction on the Wutchumna for a broken meter valve October 1. Mark Davis was asked how he was liking the SCADA system on the 69 Line of which he replied, "I love that thing."

GROUNDWATER LEVELS

The average depth to groundwater for the month of March was reported at 103.9 feet. This was an increase in the depth to water of 2.0 feet from the prior month.

SUSTAINABLE GROUNDWATER MANAGEMENT ACT

It was reported that the 218 Election was being delayed till the end of September to get more public outreach/education out to the public. Manager Weddle also stated that the East Kaweah GSA was working on a policy list for its groundwater sustainability plan.

MANAGERS REPORT

The Board discussed the new point of diversion for the District into the Cottonwood Ditch. It was suggested that we determine the maximum potential diversion into Cottonwood to see if improvements are needed to take advantage of maximum recharge.

SOUTH VALLEY WATER ASSOCIATION

Dan Vink discussed the Friant Kern Canal Funding Strategy along with the short and long term ASO funding plans.

CLOSED SESSION

The Board went into Closed Session to discuss the Westlands Water Rights filing.
